*The NAWT One-day Inspector Certification Course does not replace the required application and testing process for certification in Kentucky. Each attendee (that chooses to become certified to install systems in Kentucky) of the NAWT Inspector Course must still make application and pass the Onsite Sewage Disposal Systems Test which is given through their local county health department in Kentucky or the Frankfort office.

CEU Process:

- WWETT will submit your attendance to Kentucky Department for Public Health.
- The information WWETT needs from each attendee to successfully submit training is:
 - Your certification number (include this number when you register for the show on the personal information page in the Continuing Education section.)
 - Provide the last four digits of your social security number on a sign in sheet outside the door of your first session. (This is necessary only once – not for each session you attend.)
 - You must also be scanned at the door of each session.
- An email notification will be sent approximately six weeks post show with instructions to download your certificates of completion.
- Attendee will download or print earned certificates and keep on file for your own records.
