



## Water & Wastewater Equipment, Treatment and Transport (WWETT) Show Sustainable Booth Award Contest OFFICIAL RULES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN.** OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES, DISTRICT OF COLUMBIA THAT HAVE A VALID DRIVER'S LICENSE OR TAX I.D. NUMBER, WHO ARE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID WHERE PROHIBITED. **HOW TO WIN:** All submissions will be reviewed by a panel of three (3) judges comprising of WWETT Group Leader Marc Acampora, WWETT Senior Event Operations Manager Sydney Rhea, and Fern Account Executive Mackenzie Forester. Each nomination will be judged based on the following criteria: booth build, shipping, employee travel, promotional items and handouts, and assessment on-site during the February 17-19, 2026 Expo. WWETT will select and announce one (1) winner on or about March 31<sup>st</sup>, 2026, from all eligible winners received by WWETT. The decision of the panel will be final and non-appealable.

The potential winner will be notified by email and will be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within seven (7) days of date of issuance and a W-9 form. If such documents are not returned within the specified period, prize notification is returned as undeliverable, or a potential winner is not in compliance with these rules, Prize will be forfeited, and, at WWETT's sole discretion, an alternate winner maybe selected.
